## 1. Call to Order.

3. Consideration and approval of the September 5, 2012 meeting minutes.

Several examples of variance requests and their outcome were given to the members, showing how the BOA is envisioned to process various types of requests.

Brief discussion was held regarding the board training sessions that were held in September and early October stating these trainings will be offered annually in the future.

Joseph Willrich with Befoc Engineering Company addressed the Board giving a presentation on granite driveways. Mr. Willrich presented handouts to the members and discussed granite driveway details, excerpts from the City's Zoning and Subdivision Ordinance and gave stabilizer literature information to them as well.

Melissa McCollum updated the Board on the Planning and Zoning Commission's decision not to revise the decomposed granite driveway portion of our Code. This decision was put before the City Council who agreed with the Commission's decision to leave the Code as it currently is.
